Key events

Eurozone: Trade Balance Jun'25

Domestic

S&P Global upgrades India's rating to 'BBB' (Source: S&P Global): It has upgraded India's sovereign credit rating to 'BBB' from 'BBB-', citing economic resilience, sustained fiscal consolidation, and robust growth. It said the stable outlook reflects confidence in continued policy stability and infrastructure investment. Despite US tariff concerns it sees the impact as manageable.

PM Modi announces key policies in his Independence Day speech (Source: BS): PM Modi outlined new economic and security initiatives, including a GST overhaul, a Rs. 1 trn scheme for first-time job seekers, indigenous semiconductor production, and Mission Sudarshan Chakra, aimed at safeguarding strategic and public sites.

WPI contracts for second straight month in Jul'25 as food and fuel prices recede (Source: PIB): WPI slipped to -0.58% y/y in Jul'25 (Jun: -0.13%), with slowdown across segments. Primary articles fell 4.9% y/y in Jul'25. Fuel and power declined by 2.4%, while manufactured products rose a tepid 2.1% in Jul'25 as base metal prices fall.

Merchandise trade deficit widens on-year in Jul'25 (Source: PIB):

- Merchandise exports rose by 7.3% y/y at USD 37.2 bn. Imports grew by 8.6% to USD 64.6 bn. Accordingly, deficit widened to USD 27.4 bn
- Services exports grew by 1.4% y/y to USD 31.0 bn, while imports declined at 3.4% to USD 15.4 bn, resulting in surplus of USD 15.6 bn
- Trade deficit in Jul'25 was USD 11.7 bn and 4MFY26 at USD 31.3 bn

Passenger vehicle wholesales down marginally in Jul'25 (Source: SIAM): Total production across vehicle categories stood at 2.7 mn units, with domestic sales of PVs reaching 341k units down 0.2% y/y. 2W sales grew 8.7% to 1.56 mn units. 3W sales grew by 17.5% to 690k.

Union mulls GST overhaul (Source: ET): As per media sources, Union is considering a significant overhaul of the GST structure, proposing a simplified regime with just two main tax slabs of 5% and 18%, along with a special 40% rate. About 99% of items taxed at 12% are likely to be moved to 5% slab. Similarly, ~90% of 28% slab to 18% category.

International

US producer prices heat up in Jul'25 (Source: US BLS, Bloomberg): PPI clocked 3.3% y/y in Jul'25 above expectations of 2.5%. Core PPI also registered above expectations and above the headline. Sequentially, producer prices rose by 0.9% m/m.

China's growth stumbles in Jul'25 (Source: CNBC):

- Retail sales grew 3.7% y/y in Jul'25, slower than 4.8% y/y in Jun'25 and expectations of 4.6% y/y due to extreme weather across country
- Industrial production slowed to 5.7% y/y in Jul'25, slipping sharply from 6.8% y/y in Jun'25, its weakest since Nov'24
- Fixed asset investment slowed drastically in 7MCY25 to 1.6% y/y, from 2.8% y/y in 6MCY25, exacerbated by extended housing slump
