Union mulls easing trade restrictions on Chinese imports to spur growth (Source: ET): According to media sources, Union is considering easing certain tariff and non-tariff restrictions on Chinese imports including allowing lapsing on anti-dumping duties on certain products and cutting tariffs on raw materials for sectors like leather and engineering goods, where supply is limited, to spur industrial growth.

MPC member sees scope for further monetary easing (Source: FE): Prof. Ram Singh interjected that benign inflation outlook, signs of private investment recovery and global rate environment make space for rate cuts, with any stress in growth reinforcing the case. He has flagged headwinds from fluid geopolitical scenario for dampening growth momentum, while exuding comfort on currency scenario.

Union official lauds GST measures in festive sales boost (Source: FE): FM Ms. Sitharaman and Commerce Minister Mr. Goyal highlighted that benefits of rate cuts have passed on to consumers across 54 products monitored by Union, boosting festive season consumption.

G-Sec auctions conducted successfully (Source: RBI): 6.01% GS 2030 worth Rs. 180 bn was auctioned at cut-off yield of 6.1252%. 7.09% GS 2074 worth Rs. 120 bn was auctioned at cut-off yield of 7.1782%

International

China HFIs signal mixed optimism (Source: Bloomberg):

- China GDP rose 4.8% y/y in Q3CY25, in line with expectations. This is a slowdown from 5.2% seen in Q2
- Retail sales rose 3% y/y in Sep'25 (Aug'25: 3.4% y/y)
- Industrial production rose 6.5% y/y, exceeding expectations
- Fixed asset investment dipped 0.5% y/y in Sep'25, driven by 13.9% y/y slump in property investments which weigh on growth prospects

PBoC keeps benchmark rates unchanged (Source: Reuters): PBoC held the 1Y loan prime rate at 3% and 5Y LPR at 3.5%, as per expectations, amidst slowing growth momentum and simmering trade tensions

POTUS approves support measures for auto production (Source: Bloomberg): Mr. Trump signed an executive order that makes automakers eligible for credit equal to 3.75% of retail price for assembled vehicles, engines, and medium-heavy duty truck production to offset tariff impact, while setting 25% tariffs on imported medium and heavy-duty trucks with effect from 1 Nov'25.

US Fed official supports cautious rate cuts (Source: Reuters): Mr. Musalem supports another rate cut if risks to jobs elevate and inflation remains contained, but advocates for cautious approach with tariff impacts still flowing in the economy, amidst immigration changes.

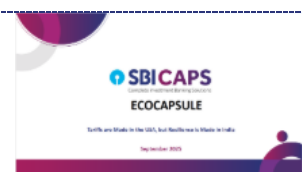
