Re: Details of Sponsor Contribution in relation to initial public offering of units (“Units”, and such issue, the “Issue”) of Raajmarg Infra Investment Trust (the “Trust”) comprising a primary issue of Units aggregating up to ₹ 60,000 million by the Trust (the “Issue”) in accordance with the Securities and Exchange Board of India (Infrastructure Investment Trusts) Regulations, 2014, as amended (the “Issue”).

In connection with the Issue, the Trust has filed the offer document dated February 28, 2026 (the “**Offer Document**”) with Securities and Exchange Board of India (“**SEBI**”), BSE Limited and National Stock Exchange of India Limited on February 28, 2026, in accordance with Securities and Exchange Board of India (Infrastructure Investment Trust) Regulations, 2014, as amended (the “**SEBI InvIT Regulations**”).

We would like to inform you that pursuant to the commitment letter dated January 12, 2026 and cash escrow and sponsor bank agreement dated February 28, 2026, National Highways Authority of India (the “**Sponsor**”), has subscribed to 90,00,00,000 Units of the Trust with a higher end of the price band at ₹100 per Unit for a cash consideration of ₹90,000 million to ensure that the aggregate unitholding of the Sponsor amounts to be at least 15.00% of the total post-Issue unit capital of the Trust in order to comply with the sponsor and sponsor group lock-in requirements under Regulations 12(3) and 12(3A) of the InvIT Regulations, considering the Issue to be fully subscribed and (“**Sponsor Contribution**”).

While the Sponsor has subscribed to the Units prior to the Bid/ Issue Closing Date, such Units shall be allotted to the Sponsor on the date of Allotment. Subsequently, the Investment Manager (on behalf of the Trust) shall utilize the Sponsor Contribution towards the objects of the Issue specified in the section titled “*Use of Proceeds*” on page 211 of the Offer Document.

All capitalised terms used but not defined in this letter (including annexure hereto) shall have the meaning ascribed to such terms in the Offer Document.

We request you to kindly take the same on record.


