India: SGS Auction; **China:** New CNY Loans, TSF Mar'26

Domestic

RBI proposes refurbishment of NBFC rules (Source: RBI, CNBC): The draft proposes to replace existing methodology with asset size criteria, and NBFC-UL shall have asset size of Rs. 1 trn and above as per latest audited balance sheet for the financial year. This threshold shall be reviewed every 5 years. Eligible government owned NBFCs may now come in NBFC-UL. Further, to the extent that a State Government guarantee is used for offsetting exposures by NBFC-UL, the exposure shall shift to the State Government with applicable risk weight of 20%.

Mutual fund flows suffered in FY26 as markets became choppy (Source: AMFI, CEIC): In FY26, net inflows into mutual funds totalled Rs. 7.4 trn, down 9.7% y/y. This was owing to an 84% drop in inflows to debt-oriented funds to Rs. 221.6 bn, with equity-oriented funds seeing a shallower drop of 16.9% to Rs. 3.5 trn. Hybrid funds showed resistance, rising by 30%. In Mar'26, debt funds saw outflows of Rs. 2.9 trn, the biggest monthly outflow since atleast Apr'29. Inflows into equity and hybrid funds could do little to offset this huge outflow.

General insurers grew well in FY26 (Source: CEIC): In FY26, gross direct premia raked in by non-life insurers amounted to Rs. 3.4 trn, up 9.3% y/y, with magnificent collections by specialised health insurers. Growth of public and private insurers was neck and neck. In Mar'26, gross direct premium clocked Rs. 289 bn, up 8.8% y/y, with private players leading public insurers in the month.

E-way bills hit a record in Mar'26 (Source: BS): Registering a 13% y/y surge to 140.6 mn, e-way bills surpassed the previous record set in Dec'25. This augurs well for collections in Apr'26.

Windfall levies on oil exports raised (Source: ET): Export duty on diesel has been raised to Rs. 55.5/L from Rs. 21.5/L. Excise duty on high-speed diesel is now Rs. 24/L, now Road & Infrastructure Cess is at Rs. 36/L. Duty on ATF is spiked to Rs. 42/L from Rs. 29.5/L.

International

World plunges in chaos once again as US-Iran talks fail (Source: The Guardian): The talks in Islamabad did not reach a fruitful conclusion after 21 hours. The American side claimed that Iran refused to give up its nuclear ambitions. The Iranian side said American demands were excessive and they did not expect talks to conclude in a single round. In the aftermath, the POTUS claimed that that the US would blockade Iran and impose 50% tariff on China if it supports Iran militarily.

US CPI surges in Mar'26 (Source: BLS, Reuters): Consumer prices rose 3.3% y/y owing to a 18.9% surge in gasoline prices, which drove up energy inflation. Core inflation clocked 2.6%, above the Fed's target. Sequentially, CPI accelerated to 0.9% m/m, owing to 21.2% jump in gasoline prices as the War took its toll. Ms Daly of the US Fed said the oil shock will make the descent of inflation slower.

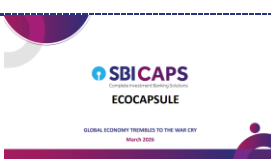
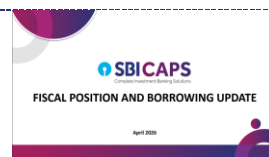
